## Marine Protected Areas Federal Advisory Committee Meeting Scheduled for Sept. 9 – 11, 2009 in Anchorage



The Marine Protected Areas (MPA) Federal Advisory Committee, which advises the U.S. Departments of Commerce and Interior, will hold its 14th meeting on September 9 - 11, 2009, at the Hilton Anchorage Hotel in Anchorage, Alaska. The Committee will hear two expert panel presentations. The first presentation will examine how the National System of Marine Protected Areas can contribute to ecological resilience in the face of climate change. The second presentation will focus on including management agencies and stakeholders in marine protected areas in Alaska. The meeting will concentrate on the completion of draft recommendations developed by the Scientific & Technical, and Review & Evaluation, Subcommittees for deliberation and action by the full Committee.

**WHAT:** 14th meeting of the Marine Protected Areas Federal Advisory Committee. Attendance is open to any interested individuals. Two public comment periods are scheduled: Wednesday, September 9, 2009 from 4:30-5:15 p.m. and Friday, September 11, from 8:45-9:30 a.m. Panel discussions are

scheduled for September 9 and 10. Subcommittee meetings are scheduled on all three days.
